



**Sub: HOLDING OF THE SCREENING COMMITTEE MEETING TO BE HELD ON 30.05.2022 TO CONSIDER COMPASSIONATE APPOINTMENT IN NATIONAL HANDICRAFTS AND HANDLOOM MUSEUM, PRAGATI MAIDAN, NEW DELHI.**

The DSC meeting was convened for consideration of cases of compassionate appointment in respect of Gropu 'C' posts falling vacant under 5% direct recruitment quota in the Office of National Handicrafts and Handloom Musuem (NHHM), Pragati Maidan, New Delhi.

2. DSC was provided with detailed instructions/guidelines about implementation of the schemes of compassionate appointment as envisaged in the DOP&T O.M. No. 14014/02/2012-Estt. (D) dated 16.01.2013 and other instructions issued in this regard from time to time.

3. DC(Handicrafts) vide note at page 4/ante has approved composition of the DSC as follows for considering compassionate appointment:-

4. The last DSC meeting held on 19.02.2019 for consideration of cases for compassionate appointment in respect of NCM&HKA was held on 19.02.2019 when Smt. Sushma, Wife of late Shri Naresh Chand, Chowkidar was appointed on compassionate grounds against the vacancies taken into consideration upto the period 31.01.2015 to 31.08.2018. Thereafter, the following 10 group 'C' vacancies under direct recruitment quota, have occurred during the period from 01.09.2018 to 31.12.2020 as enumerated as under:-

In terms of DoPT OM No. 43019/9/2019-Estt.(D) dated 23<sup>rd</sup> August 2021, the relative merit points and procedures for such selection being adopted by other Ministries/Departments have been studied and based on it, issued terms of reference vide Museum's O.M. dated 15.12.2021 so as to bring about uniformity in the selection procedure. All 7 applicants were provided with the copy of the said OM along with blank application form vide for submission of latest information/status of their financial positions along with other declarations and related documents.

6. The applications from the aforesaid 07 aspiring candidates for consideration of appointment on compassionate grounds, have been received in NCM&HKA.

7. The committee was further informed that on the basis of initial scrutiny of the information and supporting documents furnished by all 7 candidates for compassionate appointment, a comparative statement is prepared indicating details of relative merits points and points scored by each candidate which is kept at **Annexure-3** for perusal please. The scores obtained by all 7 candidates is given below:

Further, it is also informed to the DPC that all the applicants vide letter dated 12.04.2022 (sent through e-mail as well as speed post) were provided with a copy of the comparative statement to know their points obtained and were also requested to submit their objection / or grievance, if any, latest by 20.04.2022. No representation has been received from any of them.

Accordingly, all records including applications received from applicants along with supporting documents, instructions with terms & conditions and compiled comparative statement are placed before DSC. The Committee is requested to recommend the candidate for compassionate appointment for filling up **one vacancy** of MTS available under 5% of direct recruitment quota in NCM&HKA, New Delhi.
