

Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and Other Backward Classes and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
